

Register of members' interest

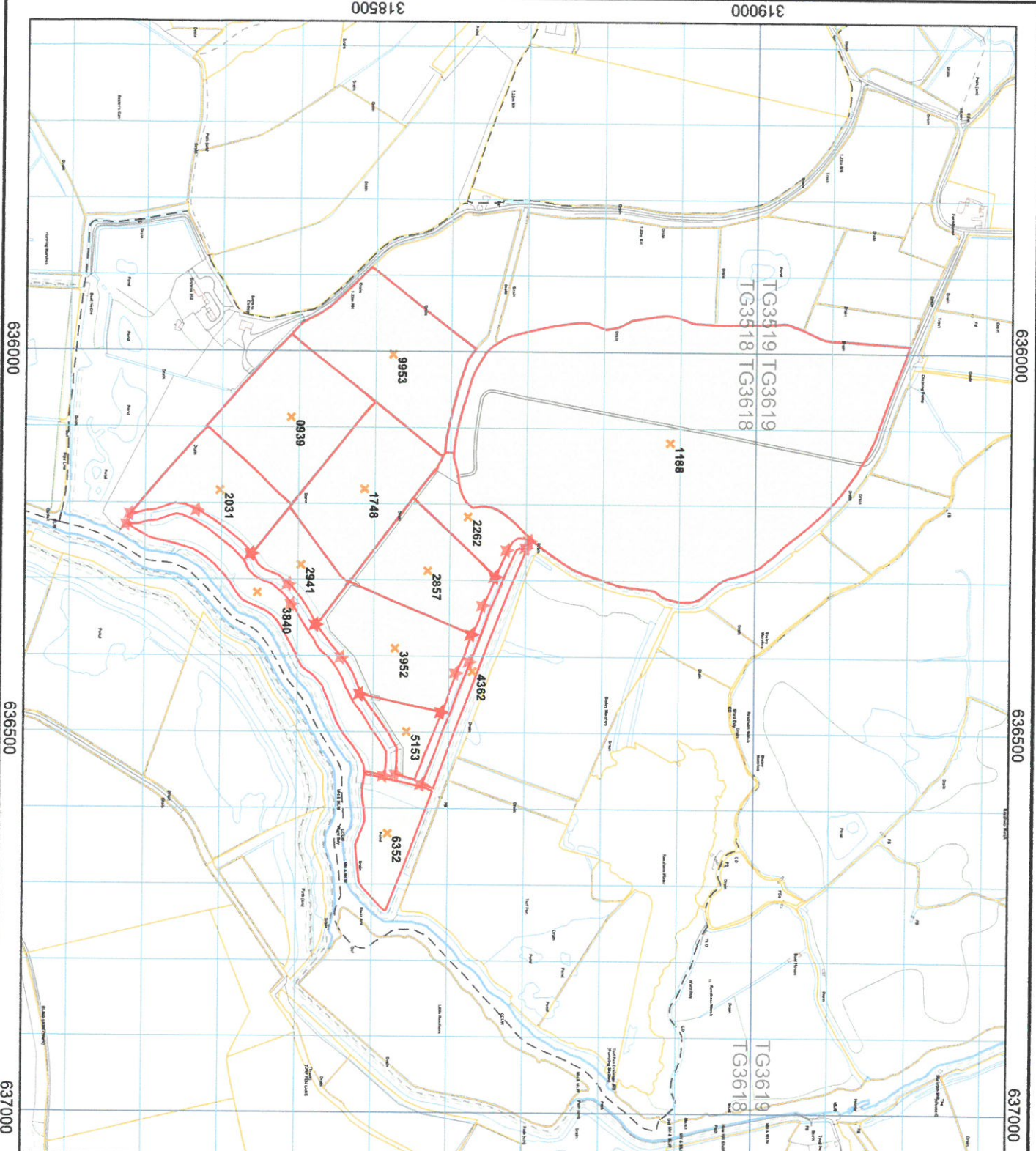
