Conditions of Sale

- 1. The items are offered for sale by the Broads Authority.
- 2. The items are offered for sale in condition as is and as lying at time of sale. No warranty is given by the Broads Authority concerning the condition of the items or any part of its or of its equipment, or its fitness for any purpose. No operating manuals, condition reports or safety reports are available. Intending purchasers should satisfy themselves concerning these matters.
- 3. No liability will be accepted by the Broads Authority for any death or personal injury to any person or damage to property arising in connection with the items unless caused by the negligence of the Authority or its officers.
- 4. Successful bidders will be notified via text or email within 5 working days after closing date of bids.
- 5. The purchaser will be responsible for all charges and outgoings in respect of the items purchased from time of sale.
- 6. The items purchased must be paid in full within 5 working days of receipt of invoice. All items will be invoiced with 20% VAT added to the winning bid price.
- 7. Once paid in full, all items must be collected by the purchaser from its current location no later than ten working days from date of payment. Failure to collect and remove the item by that time will cancel the sale. The collection can only be arranged between 9am-3pm Mondays to Fridays. Telehandler lift onto a suitable trailer can be provided at the point of collection.
- 8. Vessels being kept on the Broads Navigation or Adjacent Water must have in place valid insurance and have paid for a Toll before the item can be collected.
- 9. The Broads Authority reserves the right to refuse sale if payment does not clear or buyers do not make proper arrangements for collection of items.
- 10. No refunds or returns will be accepted.

Viewing

To arrange for a viewing, please call Broads Control, 01603 756056, who will provide you with the times and directions to the location of the viewing. At the viewing:

- Staff will not give assistance on the items value.
- The sale item cannot be moved from the sale area.
- The sale items cannot be climbed upon.
- Viewers will be accompanied at all times within the sales area.

- No haggling will be entered into, place your best bid to secure the item.
